Martin Waldseemüller was born in Freiburg probably in 1470 and studied mathematics and geography at the University of Freiburg. His 1507 world map grew out of an ambitious project in St. Dié, France, during the first decade of the sixteenth century, to document and

update new geographic knowledge derived from the discoveries of the late fifteenth and the first years of the sixteenth centuries. Waldseemüller's large world map was the most exciting product of that research effort and included data gathered during Amerigo Vespucci's voyages of 1501–1502 to the New World. Waldseemüller christened the new lands "America" in recognition of Vespucci's understanding that a new continent had been uncovered as a result of the voyages of Columbus and other explorers in the late fifteenth century.

Waldseemüller's map supported Vespucci's revolutionary concept by portraying the New World as a separate continent, which until then was unknown to the Europeans. It was the first map, printed or manuscript, to depict clearly a separate Western Hemisphere, with the Pacific as a separate ocean. The map represented a huge leap forward in knowledge, recognizing the newly found American landmass and forever changing the European understanding of a world divided into only three parts – Europe, Asia, and Africa.

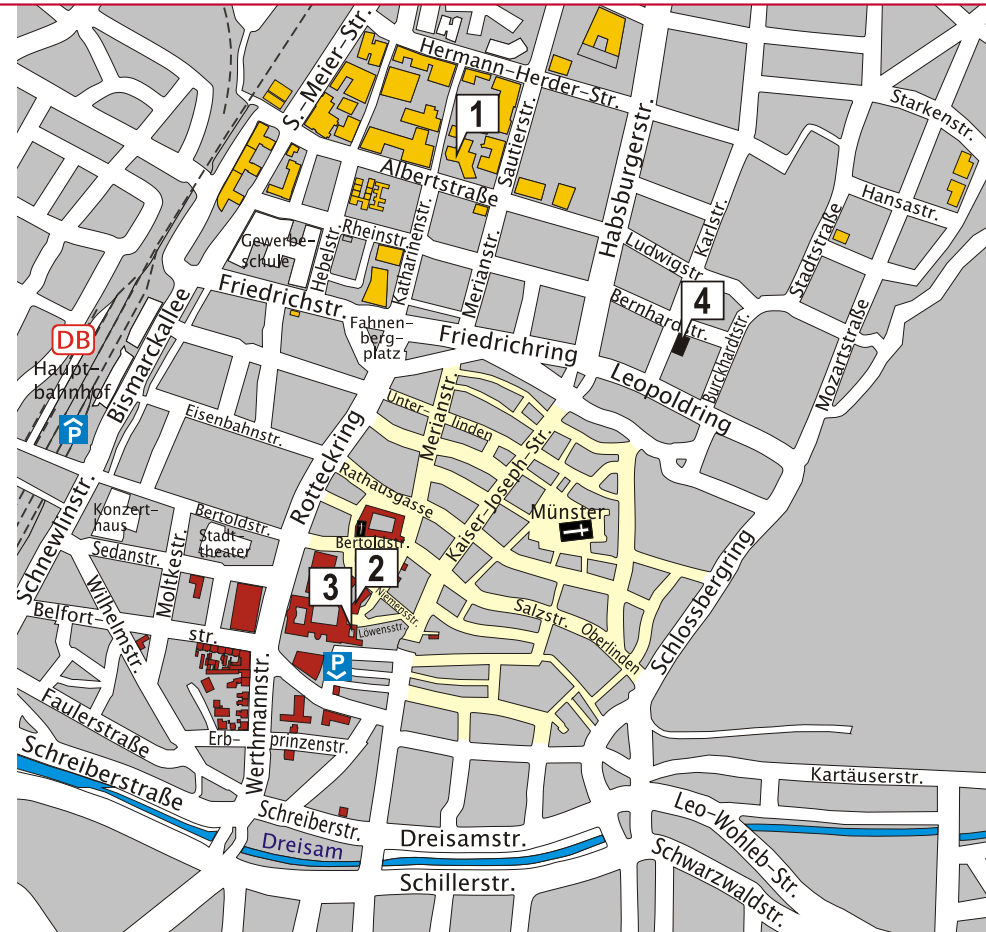

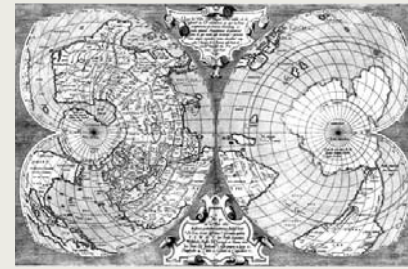

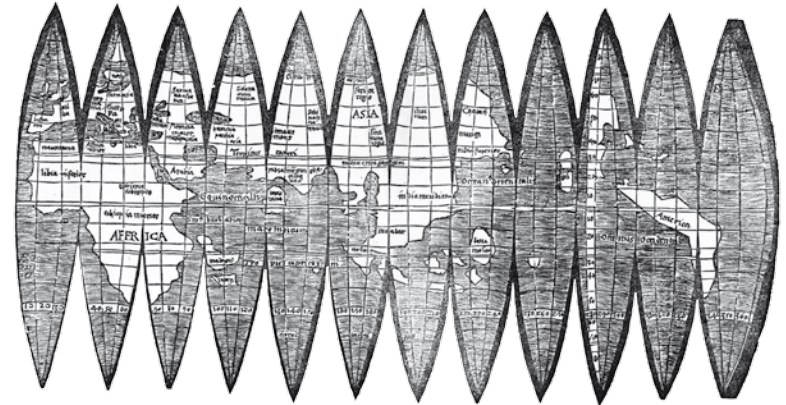

**Hendrik Geyer, Director**

Hendrik Geyer has been Director of the Stellenbosch Institute for Advanced Study (STIAS) since 2008 and Professor of Theoretical Physics at Stellenbosch University since 1990.

Before he had been a member of the Pelindaba Nuclear Development Corporation's Theoretical Physics Group for seven years, finally serving as Principal Scientist. In 2006 he was appointed Interim Director of the National Institute for Theoretical Physics (NITheP), the final establishment of which was the culmination of a long-term goal which he had pursued over a number of years. Geyer's research focuses on formal aspects of quantum theory and the quantum many-body problem. He has supervised graduate work ranging from quantum computing to an analysis of seismicity in mines, and complexity within a philosophy context. As a popular science writer he has been active for more than a decade.

The Alexander von Humboldt fellowship has twice been awarded to Geyer for a one year term, and he has held shorter term fellowships at the Institute for Nuclear Theory at the University of Washington (Seattle) on five occasions. He is an elected Member of the Academy of Science of South Africa, an elected Fellow of the Royal Society of South Africa and a member of the American Physical Society.

**Bernard Lategan  
Founding Director, Stellenbosch  
Institute for Advanced Study from  
2000 – 2008**

Bernard Christiaan Lategan (born 1938) studied ancient languages, linguistics, literature and theology at the Universities of the Free State and Stellenbosch and pursued his doctoral studies in the New Testament in Kampen and Utrecht. In 1967 he completed his doctoral dissertation *Paulus en Jesus. Die aardse Jesus in die prediking van Paulus* (Rotterdam 1967). In 2009 Stellenbosch University awarded him the degree D Phil (honoris causa). Appointed Professor of New Testament Studies at the University of the Western Cape in 1969, Professor of Biblical Studies at Stellenbosch University in 1978. Lategan specialized in hermeneutics, research in this field at institutions in North America, the Netherlands, Germany, and Sweden. He was guest professor at several of these institutions.

Lategan is the co-founder of the Centre for Interactive Redesign that developed a unique process based on hermeneutical principles for the development of common values in the work place in situations of diversity and conflict. He retired on 31 March 2008.

**Judith E. Vichniac,  
Associate Dean of Fellowship Program**

Judith E. Vichniac holds a Ph.D. from the Department of Government, Harvard University and a B.A. from Hebrew University, Jerusalem, Israel. Her publications include *The Management of Labor: The British and French Iron and Steel Industries, 1860-1918* (1990) and several articles in international scientific journals. She was coeditor of *Democracy, Revolution, and History* (1999), a *Festschrift* published in honor of Barrington Moore, Jr., sociologist at Harvard.

Vichniac taught at Harvard University, where she was Lecturer from 1981 to 1984 and Assistant Professor of Social Studies and Head Tutor from 1984 to 1989. From 1989 to 2001, she was Director of Studies and Senior Lecturer in the Committee on Degrees in Social Studies before being appointed Associate Dean of the Fellowship Program at the Radcliffe Institute in 2001.

From 1988 to 1999 Vichniac was also Program Director in the Minda de Gunzburg Center for European Studies.

**Pedro Paulo A. Funari,  
Head**

Pedro Paulo A. Funari is professor of historical archaeology at the State University of Campinas, Unicamp, Brazil, with a BA in History, MA in Anthropology and PhD in Archaeology. He was secretary of the World Archaeological Congress and is research associate of the Illinois State University/USA and Barcelona University/Spain. He is author of several books such as *Memories from Darkness* (New York, Springer, 2009), *New Perspectives on the Ancient World* (Oxford, Archaeopress, 2008), *Global Archaeological Theory* (New York, Springer, 2005), *Historical Archaeology* (London, Routledge, 1995).

His scholarly papers have been published in such journals as *Current Anthropology*, *Historical Archaeology*, *Journal of Social Archaeology*, *Revue Archéologique*, and *Archaeologies*.

At Unicamp, Funari has held several positions such as Head of the Centre for Strategic Studies. He is currently Head of the Centre for Advanced Studies, in charge of setting up the Centre from its inception in March 2010.

**Christina Chia, Assistant Director for Programs and Communications**

Christina Chia is Assistant Director at the John Hope Franklin Humanities Institute at Duke University. She manages the Institute's public programs, communications initiatives (including social media), as well as the Dissertation Working Group for advanced doctoral students across the humanities. She holds a PhD in English from Duke, where she has taught courses in Comparative Ethnic studies, Asian American Studies, and American Literature. Her current research focuses on human-animal sociality in the shadow of racism. She has presented her recent work at the American Studies Association, Animals and Society Institute, and the Society for Science, Literature, and the Arts.

**César Ades, Director**

César Ades obtained his degree in psychology at the University of São Paulo, Brazil. His master's thesis was on attention and memory in human behavior, his doctoral thesis on species-specific and cognitive aspects of behavior in an invertebrate species. His main interest has been animal behavior from a comparative, evolutionary standpoint.

Ades assisted in the foundation of the Brazilian Ethological Society in 1993 and has been active in the organization of Annual Ethological Meetings in Brazil. He is a member of the International Council of Ethologists and in 2003 chaired the XXVIIIth International Ethological Conference at Florianópolis, Brazil. In 2004 Ades participated in the establishment of the Evolutionary Psychology Group at the National Association for Research and Graduate Studies and in 2008 co-chaired the first Environmental Enrichment Conference in São Paulo. As professor and former chair of the experimental psychology department, vice-director and director of the institute of psychology of the University of São Paulo, Ades has dealt with the diversity of approaches that compose psychology and worked towards convergence. He has networked with scientists both within and outside the field of psychology with the goal of furthering interdisciplinarity in research and theoretical thinking. For several years Ades was a member of the deliberative committee of the Institute of Advanced Studies before being designated its director in 2008.

**Aron Rodrigue, Director**

Aron Rodrigue is the Anthony P. Meier Family Professor and Director of the Stanford Humanities Center, and Professor of History at Stanford University. A scholar of modern Jewish history, the history and culture of Sephardic Jews, and of the Ottoman Empire, Rodrigue's books include *Sephardi Jewry: A History of the Judeo-Spanish Community 14th-20th Centuries*, and *Images of Sephardi and Eastern Jewries in Transition, 1860-1939*. He was the Ina Levine Senior Scholar in Residence at the U.S. Holocaust Memorial Museum in 2003-2004 and is a fellow of the American Academy of Jewish Research.

**Dianne Newell, Director**

Diane Newell is a Historian of Technology and Professor of History who has spent her career examining the diffusion of knowledge in disciplines across the social sciences and humanities. She has held numerous leadership positions internationally and at UBC, where she was also Associate Dean of Graduate Studies. Newell was a Distinguished Scholar in Residence at the Institute in 2002, named Acting Director in 2003, and appointed Director January 1, 2007. In this role, she has led the Institute's strategic direction, which has focused on both reaching out to the local community and creating scholarly partnerships among the international network of advanced studies institutes to create research with lasting value and impact. Under her leadership, the Institute has expanded its facilities, programs, and information technologies to heighten its reputation as an inspiring location for high-risk research and discussions at the highest level, involving outstanding scholars at UBC and abroad.

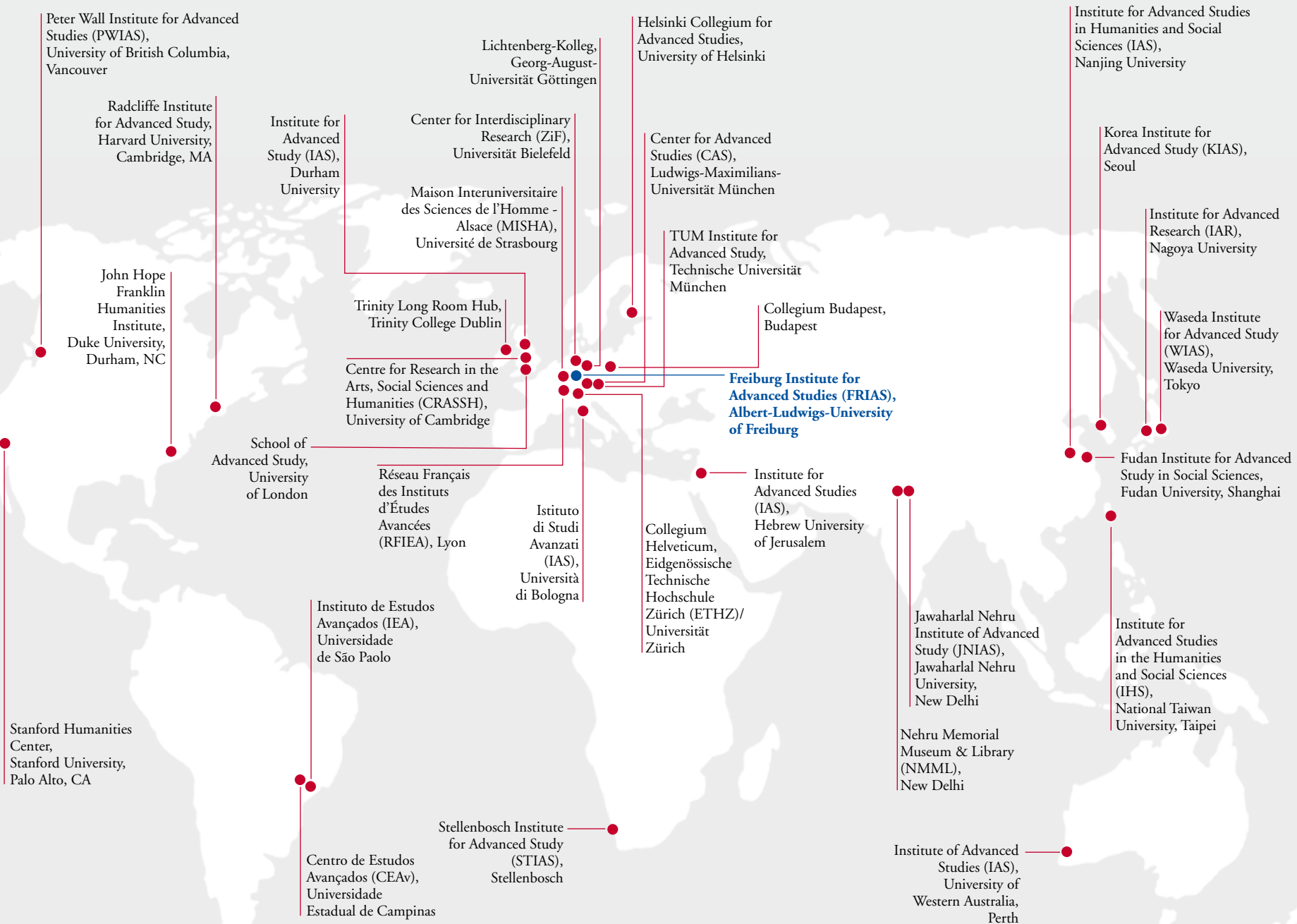

### **Kirill Ole Thompson, Associate Dean**

Kirill Ole Thompson received his Ph.D. in Chinese Philosophy from the University of Hawaii. Currently, he is Associate Dean of the Institute for Advanced Studies in Humanities and Social Sciences and Professor in the Department of Foreign Languages and Literature at National Taiwan University.

Thompson has published many articles on Zhu Xi, mostly in *Philosophy East and West*. Forthcoming works include "Opposition and Complementarity in Zhu Xi's Thought" and "Zhu Xi's Transformation of the Zhongyong." He also published several articles on classical Daoism, including a comparison of Daoism with Samuel Beckett's dramatic vision, as well as a breakthrough interpretation of Gong-sun Long's "Treatise on the White Horse." Longer projects include a monograph on Thomas Gray's odes and elegy and two studies of Thorstein Veblen. Thompson is currently compiling a source book of Chinese humanism.

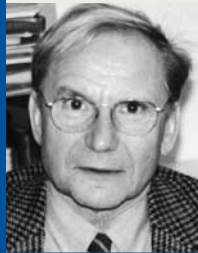

He has been a visiting professor at Stanford University, the Institut de Sciences Politiques in Paris, and at the University of Bombay in India.
